#### GENERAL INFORMATION

We have received latest information that the customs office at Tehran Fairground has been closed. As a result, all incoming freight must be customs cleared at point of entry. Airfreight at IKA Airport, truck freight at central customs warehouse and ocean freight in Bandar Abbas. This complicates customs procedures.

All goods either for permanent import (brochures, give ways etc.) or temporary import must be cleared on temporary basis first and after end of show will be declared to customs as consumed, sold or to be returned. For all goods a guarantee / bond fee is required.

Furthermore, the customs duty & taxes for some consumed articles has been increased by 200-250 % which means that handling costs of consumable items may be very expensive. All applicable embargo regulation, bans and restrictions as well as other export restrictions by the European Community are need to be observed (if any).

#### **IMPORTANT NOTES**

- Goods for temporary and permanent import may be shipped as combined goods but need to be packed separately.
- All documentation must be in ENGLISH language.
- A full description of each product / item must be given. Do not just indicate the model name or model number. Describe the item – such as "1:3 scale (cutaway) missile model" or "souvenirs – lapel pins" or "wooden display plinth – floor standing" etc.
- Every individual item, including giveaway items and brochures, is to be given a value based on FOB value expressed in Euro or U.S. Dollar.
  - Do not indicate the phrase "No Commercial Value NCV".
- It is recommended to mail copies of the commercial invoices to our office prior to shipment in order to check if there's any restrictions on the products or if there are any special import permits required.
- Please provide the Harmonized Customs Tariff for each product on the commercial invoice.
- **Certificate of Origin** is required for all goods which are intend to be sold during or after the Show and for all consumable goods except of catalogues/brochures and giveaway's.
- The import of food and beverages (no alcohol / pork meet) is very complicated and time consuming.
  - The provision of Health Certificate and Certificate of Origin is therefore mandatory. In case you ship perishables please note that there are no cooling facilities at Airport, Central Customs or Fairground. Shipping is at owners risk
- If you intend to ship **hazardous goods** (paint, gasoline, lighters etc.) please ensure that all regulation for shipping hazardous goods are fulfilled. Please avoid to ship such goods because customs clearance is very complicated.
- Videotapes / films / slides / CD should be sent 5 weeks prior to show opening to PANEXPO. We will forward them to Tehran for censorship. Fees are for account of the shipper / exhibitor.
- We must receive the Combined Commercial Invoice and Packing List not later than the deadlines shown.



- The number of packages, weight and volume should tally with the details on CMR, Air waybills, Invoices and Packing lists.
- If there is a serial number available for a product please indicate it on the commercial invoice. This will assist temporary Customs formalities.
- Exhibitors are requested to declare products correctly on all documents. In case of discrepancies arising from customs examination, Customs may impose penalties asapplicable. We do not accept any responsibilities in case of incorrect declarations by the exhibitor.
- It must be clearly stated on the commercial invoice if the goods are for temporary or permanent importation.
- For all consolidated shipments having more than one commercial invoice, a HAWB/HBL must be issued for each commercial invoice.



# CONSIGNMENT DEADLINES

All freight must arrive not later than:

Airfreight consignments 3 weeks prior to delivery to stand

Airport of destination Imam Khomeini Airport

Sea freight consignments (FCL only!) 5 weeks prior to delivery to stand

Seaport of destination Bandar Abbas

Land freight consignments 3 weeks prior to delivery to stand

# LATE ARRIVAL SURCHARGE

Late arrival surcharges (based on the basic handling rate) will be applied as follows:

Air shipments: arriving 7 days or less before requested stand delivery 25% Ocean shipments: arriving 14 days or less before requested stand delivery 50% arriving 7 days or less before requested stand delivery 25% arriving 7 days or less before requested stand delivery 25%

In any such case our local agent TRCL will make all reasonable efforts to ensure delivery before the show opens, however, no guarantees can be given. The surcharges will apply regardless of delivery date to the show site.



Please issue these documents very carefully. In case of any discrepancies and/or delays, penalties will be the result.







# **PACKING**

It is essential that cases used to transport the exhibits are of sufficient strength and can withstand unpacking and repacking operations (e.g. during customs inspections).

Cases should therefore have pre-fabricated sections and should be constructed as a bolted returnable container.

Do not use pallets as packaging material (cartons shrink wrapped on pallet) in order to ship your items to Iran. We refuse any responsibility in such case!!!

#### ISPM15

Iran has implemented the requirements of the international standard on Phytosanitary Measures (ISPM15), Guidelines for Regulating Wood Packing Material in International Trade", effective 1 January 2010. This implies that all raw wood packaging material entering and leaving Iran will have to be treated and marked in accordance with the requirements of ISPM 15.

# CASE MARKING

All packages, shipped either by airfreight, seafreight, landfreight or courier service must be properly marked for identification on arrival, as follows:



# STORAGE OF EMPTY CASES

Empty cases will be stored within the exhibition site if space is available. Your cases will be marked and stored systematically under shelter during the exhibition period in order to facilitate quick and early retrieval for the repacking at the end of the exhibition.



# CONTAINER DETENTION

Container detention fee will be levied by shipping lines for containers kept in use. Should you require us to keep the container for subsequent re-export, you are to inform us of the container detention fee that has been negotiated with the shipping line.

# **EXHIBITION LAYOUT PLAN**

For large or heavy exhibits, an exhibit layout plan is required by us in advance in order to position such exhibits during the early stage of the build-up period.

# **RE-EXPORT**

Exhibitors are to indicate to us on the Commercial Invoice and Packing List, the items that will be re-exported as well as the items that will be disposed of, consumed or given away at the end of the exhibition.

Disposal instructions will be taken from the exhibitors during the exhibition.

#### **STORAGE**

Neither PANEXPO nor our local agent TRCL – Tehran Rakhsh Co. Ltd. will be responsible for the condition or the contents of any goods received for storage, nor for any loss of weight and damage to the said goods before or whilst being stored or remaining in storage caused by dampness, termites, burglary, theft, Acts of God, Enemies, hostilities, strikes, lockouts, riots, civil commotions, effects of climate, monsoon, tempest, lighting, earthquake, explosion, vermin, white ants, unprotected or insufficiently packing or packages, obliteration or marks, book holes, tearing of covers, busting of bands of goops, leakage, rust, decay, sweat, mildew, dry rot, evaporation, fumigation, accidents and / or the latent defect of the storage containers.

The company may refuse to deliver to any person the goods deposited unless the storage charges accrued are paid.



# **CUSTOMS DUTY**

The "Custom Authorities" levy customs duty on all goods coming to Iran, which are sold/consumed/destroyed regardless if they are re-exported at the end of the show. Please note that customs duty is applicable on all brochures, give-aways and gift items being shipped to the show, immaterial if they are consumed or shipped back to origin. All these shipments are cleared on a basis against payment of 40% on CIF(cost, insurance, freight)-value of the goods as assessed by Iran customs or a minimum of USD 200 per shipment. All customs duty assessments are solely up to the discretion by Iran customs. Iran customs can re-evaluate the value declared on the invoices and the duty is calculated and outlaid as assessed by the Iran customs.

#### TEMPORARY IMPORT

Temporary import is allowed under temporary import bond (TIB) lodged with Iranian Customs. **Temporary Import Bond (TIB)** 

Our local agent TRCL can facilitate a TIB subject to a TIB Fee (Non-Refundable) at 6.0% of CIF value or customs appraised value, whichever is the greater.

Validity of TIB is 1 months from date of entry. Extensions can be arranged subject to Custom's approval and additional TIB fee at 6% of filed value with Customs per month.

#### **ATA Carnet**

You can also use the ATA Carnet. New regulations allow complete sale out of ATA Carnet. After the event goods have to be transferred to customs bonded warehouse for final clearance.

#### CARGO INSURANCE

Upon written instructions, PANEXPO can offer you insurance coverage at competitive premiums.

#### TERMS OF PAYMENT

**Inward**: Basic inward charges must be paid before arrival of the goods. Balance of charges to be paid upon receipt of final inward invoice (after arrival of goods at port or airport of destination – **prior release of consignment)** 

**Outward:** Upon presentation of invoice, prior to export/delivery, prior release of Bills of lading All payments must be made without any deductions or deferment on account of any claim, counterclaim or off-set. Personal or foreign cheques are not acceptable. Payment must be made by bank transfer to our bank account.

PANEXPO retains the right to withhold delivery of any freight until all invoices/charges are settled in full.



# ON-SITE REPRESENTATIVE

Experienced representatives will be on-site to supervise customs clearance and freight handling and to liaise with exhibitors during the course of the event.

# TRADING CONDITIONS

We operate exclusively in accordance with the Allgemeine Deutsche Spediteurbedingungen 2016 ("ADSp 2016") (German Freight Forwarders' General Terms and Conditions 2016). Pursuant to clause 23 of ADSp 2016, liability for loss and damage of goods, which is limited under Section 431 of the German Commercial Code (HGB) to 8,33 Special Drawing Right per kilogram (SDR/kg), is further limited to the higher of Euro 1 Million and 2 SDR/kg per claim provided that all claims per event are limited to the higher of Euro 2 Million and 2 SDR/kg; and where multimodal transport with sea carriage is involved to 2 SDR/kg.
